#### **Our Work**

#### Litigation

iProbono Sri Lanka provides pro bono legal support and representation to vulnerable communities including LGBT+ persons, women and children. We work to create systemic shifts in law and policy to ensure equal rights for all.

## **Advocacy**

We are dedicated to advocating for positive social change and work with local, national, and international policymakers, civil society partners, and government bodies to inform legislative agendas. Our work has demonstrably influenced policy in cyber violence, sexual and gender-based violence, and decriminalisation of same sex relations. With the National Transgender Network (NTN), we drafted Sri Lanka's groundbreaking Transgender Rights Protection Bill. We also provided inputs to the Women's Empowerment Act during the bill stage for the advancement of women's rights and for the establishment of the Women's Commission.

## **Capacity Building**

We conduct workshops, trainings, and roundtables to build skills and expertiese for our partner organisations and legal professionals in Sri Lanka.

#### iProbono's Access to Justice Program

Since 2021, our Access to Justice (A2J) program takes young and early-career lawyers through intensive three-day residential workshops that are led by expert trainers. Participants acquire the tools they need to provide effective legal representation for marginalised communities. These lawyers can then act as critical "first responders," ensuring immediate legal support and advocacy for vulnerable women, children and the LGBT+ community. Since 2023 we have expanded the program to include police officers and activists in 2023. The program is supported by the US Embassy in Sri Lanka and our partner organisation Sri Lanka Unites. We aim to expand the trainings to include rural communities, and create a nationwide network of lawyers.



# **Storytelling**





In 2022, iProbono collaborated with Pulse to launch Stigma, a talk show featuring the perspectives of Sri Lankan activists, experts and individuals from underrepresented communities. Across two seasons, the series gained over 2.9 million views, working to dismantle negative stereotypes and shift public opinion. From a survivor's recount of societal neglect after childhood sexual abuse to a woman's experience with an unsafe abortion, Stigma highlighted powerful personal stories, aiming to foster empathy and create lasting social change.
